The Deputy Mayor, Mr John Wells addressed the meeting. Mr Wells spoke at length on the dealing of Council regarding waste.

The exciting news, is that the Council is investing in a Resource Recovery Park which will ultimately reduce the amount of waste in land fill to a very small amount.

Bayswood Update

1 Work on path between Bayswood and the Leisure Centre is still under construction but very slow 2 Concerns as to the suitability of Council staff undertaking an audit in accordance with the resolution of the Development Committee as at its meeting May 5, 2015. The Development Committee resolving in part that *"The General Manager undertake a full audit of the earlier stages of the* Bayswood state development in respect of the developers compliance with the conditions of development consent and other plans made under the consent such as, but not restricted to traffic management, landscaping and stormwater management plans". Given this was 12 weeks ago we hope some progress has been made with the audit. At this time, to my knowledge, no information/update on progress has been provided to landholders. "We will be taking on board your suggestion of lower shrubs and will be using *Lomandra longifolia (native grass)* planted at a density of 4 / square metre in areas where we believe view lines may be impacted such as outside 328 and 330 Elizabeth Drive. This will address your concerns about views and also address the need to ensure we have sufficient root penetration to stabilize the surface."
